#### FEASIBILITY STUDY

**Feasibility study (FS)** means technical, financial, economic, legal and environmental assessment and evaluation of key risks and viability of a PPP project (PPP Law 2012, no definition in the PPP Law 2019).

#### **PUBLIC AND PRIVATE PARTNERS' OBLIGATIONS**

 Rights and obligations of the public and private partners specified in the PPP Law

#### **PUBLIC FINANCIAL SUPPORT**

- Types of public financial support and their availability in practice
- Preferential loans
- Bank guarantees
- Guarantees securing performance of the public partner's obligations
- Tariff subsidies
- Direct co-financing (providing part of financial means necessary for the PPP Project implementation)



- Tax exemptions, and/or suspensions, and/or extension of terms as prescribed by the KR laws
- Customs duties exemptions, and/or suspensions, and/or extension of terms as prescribed by KR laws

#### PUBLIC ECONOMIC SUPPORT

- Types of public economic support and their availability in practice
- Rights to movable or immovable property other than the PPP facility
- Assistance with obtaining licenses, permits and consents
- Easement over movable and immovable property held in public (state and/or municipal) ownership



- Right to collect fees/tariffs and to receive proceeds from other types of activities not directly related to the PPP Project
- Preferential rates of lease payments for use of public (state and/or municipal) property
- Exclusive right to engage in activities specified in the PPPA in accordance with KR laws
- Other types of public economic support not inconsistent with the KR laws



#### TRANSFER OF IMMOVABLE PROPERTY RIGHTS

- Transfer/grant of land rights to the private partner for the PPP Project
- Grant of land to the private partner but not to the project company
- Preparing land-use planning and other documentation
- Approval of the Planning Documentation by the competent government and/or local self-government authorities
- Formation of the land plot at the stage of selecting the private partner
- Chargeability of temporary land use rights
- Land lease agreement



- Reimbursement of expenses incurred by the MoH when drafting/preparing Planning Documentation
- Limited land rights of foreign persons
- Possible prohibition on pledge of state or municipal property
- Grant of right to state and municipal immovable property
- Term of lease agreement for municipal land plots



#### TRANSFER OF RIGHTS OVER MOVABLE PROPERTY

- Grant of rights over movable property
- Possible restriction on pledge of state or municipal property

#### MONITORING PROCEDURE AND PERFORMANCE MANAGEMENT

- Authorities responsible for monitoring and performance management of PPPs
- MHIF monitoring requirement
- Private partner's reporting obligations
- Monitoring procedure and performance management



#### **QUALITY CONTROL**

- Quality control by the MAC (Medical Accreditation Commission)
- Quality control by the MoH, SanEpidSupervision (Sanitary and Epidemiological Supervision – Department of prophylactics and state sanitary and epidemiological supervision), State Inspectorate for Environmental and Technical Safety of the Government (SIETS)
- Quality control by the MHIF
- Quality standards for dialysis

#### **TAXES**

- Overview of taxes applicable to the private partner
- Exemption from VAT on supplies of goods, works, services, made by the private partner and/or project company in the process of implementing the PPPAs to be approved by the Government
- Taxation of amounts received under Single Payer System



#### **CUSTOMS REGULATION**

- General overview of customs regulations applicable to the private partner
- Deferred payment and/or payment by installments of customs duties is permitted only in accordance with the Customs Union Treaty establishing grounds, conditions and procedure for alteration of customs duties payment period
- No deferred payments and/or payment by installments of VAT on import is allowed without a prior decision of the Government

#### **ANTIMONOPOLY REGULATION**

- Antimonopoly regulation
- State and municipal preferences according to antimonopoly laws



#### **TERMINATION: EVENTS AND COMPENSATION**

Termination of the PPPA and compensation issues

#### **BANKRUPTCY/LIQUIDATION**

- Bankruptcy
- Liquidation

#### **DISPUTE RESOLUTION**

- Disputes resolution by international commercial arbitration
- Enforcement of foreign arbitral awards in the KR



# MECHANISMS OF PROTECTION OF PRIVATE PARTNER'S RIGHTS GOVERNMENT PROTECTION GUARANTEED TO THE PRIVATE PARTNER UNDER THE PPP LAW

- Types of government protection guaranteed to the private partner under the PPP Law
- Public partner's non-interference in the business affairs of the private partner
- Protection of property of the private partner against nationalisation or any other similar process in accordance with KR laws
- Free possession, use and disposal of investments in the PPP Project and proceeds therefrom for the purposes consistent with KR laws



- Free conversion of local currency into any foreign currency and free export or repatriation of the proceeds from the PPP Project
- Compensation for losses of the private partner resulting from illegal acts or omissions of public authorities or their officials
- Revision of the PPPA terms or early termination and compensation for losses resulting from changes in KR laws making the terms of the PPP Project less favorable for the private partner than the initial terms of the PPPA



## INVESTOR PROTECTION GUARANTEED UNDER THE LAWS (APART FROM THE PPP LAW) AND TREATIES OF THE KR

- Investor protection under KR laws (apart from the PPP Law)
- Investor protection under bilateral treaties
- Investor protection under multilateral treaties

- Financial institution

#### FINANCING INSTRUMENTS

- Instruments of private financing of the PPP Project

#### **ASSIGNMENT OF RIGHTS TO THE FINANCIAL INSTITUTION**

- Assignment of rights of the private partner under the PPPA
- Direct agreement



#### **TENDER**

#### PPP PROJECT PREPARATION

- Government/MoE (Ministry of Economy) approval of a proposal on initiating the PPP Project and Tender Documentation
- Lack of time frames for adoption by the MoH of the decision to initiate the PPP Project, notification and coordination of the decision to initiate the PPP with the MoE and MoF (Ministry of Finance)
- 30-day period limitation for adoption and coordination of the MoH's decision to appoint the tender commission, develop the tender rules and Tender Documentation



- Composition of the tender commission
- Requirements for the number of bidders
- Making changes and additions to bids, tender rules and Tender Documentation during the tender process



#### PRIVATE PARTNER SELECTION

- Lack of time frames for publishing the invitation to participate in prequalification
- 30-day period limitation for submission of bids for participation in prequalification
- Lack of provisions in legal acts allowing the tender commission to hold negotiations with the bidders
- Lack of provisions in legal acts allowing the public partner to make changes and additions to the draft PPPA after holding negotiations with the successful bidder
- 60-day period for executing the PPPA between the public and private partners



 Requirement for MoH to evaluate the PPP Project impacts after holding negotiations with the private partner and receiving expert examination report and approval from the MoE and MoF

#### PRE-QUALIFICATION REQUIREMENTS

- Documents submitted by the bidders for the participation in the tender
- Evaluation of the bid and of compliance with the pre-qualification requirements
